Comments to the price list:

- 1) Rate for kWh applies to volume of electric energy consumed in the course of a recharging session, which is measured by and transmitted from the recharging point. This information is provided to you in the Apps and on the charging station display, if the station is equipped with it. Due to state of technological development, the volume may be different from value measured in your vehicle because of the point's own consumption, losses in the recharging infrastructure (current conversion for DC charging), parameters of vehicle or other technical reasons. Connection time equals time of continuous connector's connection to your vehicle irrespective of time of recharging.
- 2) "AC" refers to recharging point (such as connector) capable of recharging by alternating current power.
- 3) "DC" refers to recharging point (such as connector) using direct current. Our DC recharging points may have a different nominal maximum output, for information on the maximum output of the recharging point please see information in our Apps. This is irrespective of the fact that real output of your recharging may be lower due to your car's technical specification, multiple vehicle power distribution management of the charger or for other technology-related reasons.
- 4) Monthly fee is a fixed fee which applies to a calendar month of service provision.
- 5) The purpose of the rate for minutes is to make the charging point available to other customers as quickly as possible after the charging process is completed. The rate applies to the period in which the customer's connection time in one session exceeds the free time and applies to each commenced minute. The fee does not apply to AC points (connectors) at GreenWay's own stations from 9:00 p.m. to 7:00 a.m. the next day.
- 6) The price may vary among the recharging points and is presented in the Apps.
- 7) Recharging card allow client's authorization at the charging point and initiation of the recharging session. Only one RFID can be activated for each driver's account.
- 8) Applies to an order to start a charging session by the Operator of the GreenWay Support Center in a situation where it is not necessary due to incorrect operation of the charging station or mobile application.

ARTICLE 2 – PRICE CALCULATION AND PAYMENTS

- 2.1 The amount due for our recharging services shall be calculated as sum of (i) price component based on rate for kWh specified in this pricelist, and (ii) price component based on rate for minutes specified in this pricelist. In cases of charging at partners recharging points or at GreenWay's roaming partners network, the amount due shall be calculated according to the price (amount and how it is calculated), which you may find after log in to the Apps. The amount due shall be calculated for each recharging session separately.
- 2.2 The price for recharging services shall be increased by monthly fee, if applicable under the subscription program. In case the price program applies to a part of the calendar month only, the monthly fee will be paid in the proportionate amount.
- 2.3 We will request an authorization of your card in the amount of: (i) up to PLN 1 in the case of a preliminary authorization for a customer registered under the Standard pricing plan, (ii) an amount equal to the first monthly fee (or a proportional part thereof) in the case of a preliminary authorization for a registered customer with a subscription plan, and (iii) amounts of up to PLN 250 in the case of using the one-time charging service.
- 2.4 In order to secure payment, we reserve the right to: (i) block funds on the payment card (preauthorization) in an amount of up to PLN 250 or a higher amount specified by you in the customer account settings, or (ii) collect the full fee for the charging session after its completion. If payment is not completed by way of preauthorization or after the charging session, it will be collected at the time the VAT invoice is issued. Charges for other services and products are incurred at the time of their delivery or dispatch.
- 2.5 Payments for our services are collected automatically from the payment card registered by you in our Apps, or via payment through a payment terminal available for one-time charging, at the moment the relevant fee becomes due, or—if such payment cannot be made at that time—at a later date when the funds available on the card allow us to collect the required amount. If an attempt to block or collect funds from the payment card is unsuccessful, access to our services will be blocked each time. Services may be unblocked once all outstanding amounts have been settled.
- 2.6 Under the standard offer for customers registered for multiple recharging sessions, an invoice for charging services is issued on the day following the completion of the charging session. We reserve the right to change the billing period to monthly in dedicated offers.
- 2.7 The invoice for the first monthly subscription fee (or its proportional amount) is issued on the same day, and for subsequent months—by the 10th day of the month. An invoice for other services or products is issued within a maximum of 7 days.
- 2.8 Fees for roaming charging services may be calculated and invoiced separately after receiving data from our roaming partner. In such cases, the amount is collected on the invoice issue date.

ARTICLE 3 – CHANGE OR TERMINATION

- 3.1 You can select a new price program once a month with effect (i) from the selection moment, if there is no monthly fee payable under your current price program, (ii) from 1st day of next calendar month, if there is a monthly fee payable under your current price program (one full calendar month of an active paid plan is required), or (iii) in case we change the pricelist in manner, which has impact on your current price program, from date when the pricelist starts to apply.
- 3.2 The Energia Max, Energia Plus and Energia Standard plans apply exclusively to GreenWay-owned stations. They do not apply to partner

stations (P) or roaming stations (R).

- 3.3 Starting and using a subscription program is conditioned by payment of the first monthly fee (or its proportion) payable under the price program and then no arrears in paying the fees for our services. The subscription fee is charged in advance for each month until the plan is changed to Energia Standard, regardless of whether charging sessions took place in a given billing period.
- 3.4 You can only select the subscription program for one vehicle per driver account. If more than one vehicle is found to be charged from a driver account with an active subscription program, you will lose your right to benefit from the subscription program in the month in which we found this to occur, and all charging sessions for that month under that driver account will be billed as per rates applicable in the Energia Standard program.
- 3.5 In case of arrears in payment for our services you will lose your right to use a subscription program, and the plan with a monthly subscription fee will be changed to a plan without a subscription fee from the first day of the month following the month of arrears in payments. You have the right to return to a subscription program after paying any outstanding payments.
- 3.6 We reserve right to make any changes to terms of this pricelist, including change or termination of the price programs.
- 3.7 If we change this price list, we will inform you 14 days in advance. If you do not agree with the changed terms of the price list, you can terminate the framework contract with immediate effect.
- 3.8 If the price plan you have chosen is withdrawn by us and you continue using our services, you will be assigned to the current standard price program, unless you choose a different price program from the current price list.

ARTICLE 4 – DATE OF EFFECT

- 4.1 This price list was published on April 17, 2026 and is valid from May 1, 2026.
